## Overview

- 1. You must nominate one person to be team captain
- 2. You must be able to take pictures/videos of your journey
- 3. Winners will be announced August 10th @ 6pm on Facebook and contacted via Team Captains Phone #
- 4. Prizes will be available for Pick-Up during Market Hours 8am-Noon the following Saturday August 17th
- 5. BOUNDARIES: HWY 21, HWY 110, Vineland School Rd, and Kennet Rd.

#### Rules

- 1. Have FUN!
- This is a clue and pictorial scavenger Hunt. This means you will be given clues to locations within Desoto City Limits
- 3. Team Captains Are responsible for a fully charged and working smartphone/digital camera-recorder
- 4. Teams must stay together at all times
- 5. Teams must submit rosters at time of registration. Substitutions day of are subject to approval by judges before 9am day of event.
- 6. Teams must obey all laws including traffic laws or they will be disqualified. Additionally: no cheating, no stealing, no sabotaging, no removal of hidden objects, no trespassing on private property, no indecent photos/videos.
- 7. At least one member of the group must be in the picture or video for each clue. Time/date stamps must be turned on for your pictures. Alternatively, you can use August 10th's Newspaper and pretend like it's the 80's...hehe.
- 8. Each clue must have a seperate photo/video submitted
- Teams will be awarded ONE point each picture/video of correct clue location,
   ONE point for correctly completed task, and may be awarded ONE EXTRA point for creativity.
- 10. Each team is allowed TWO mulligans and there are two opportunities for getting them:
  - A. Pay Up! That's right, a mulligan can be purchased for \$10. Use your phone to scan the QR code for mulligans.
  - B. Donate! 10 canned food items for 1 mulligan or 20 canned food items for 2 mulligans.
- 11. To use your mulligans, simply let us know which clue(s) has you stumped.
- 12. Exercise common courtesy While dealing with the public and in public spaces.
- 13. Teams must wait their turn at task locations but do not need to complete the tasks in any specific order.
- 14. We must have a signed permission slip form for any team member under 18 and an adult supervisor must be assigned.
- 15. Judges' decisions are FINAL.
- 16. Weather delay will be announced on August 9th by 5pm.
- 17. Members of the planning committee nor Judges are eligible to play.
- 18. Access to clues will be sent on August 10 @ 9am and cut off for submissions is August 10th @ 2pm.
- 19. Teams must return to the market by 2pm.
